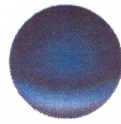
#### QUANTITATIVE COMPOSITION:

Silver – 50 ppm

Oxygen – 9,08 mg/dm<sup>3</sup>

Aqua – filled to 100%





# COLWAY

## DESCRIPTION:

**Elixir of dr Słoń** contains not known so far chemisorption combinations of (non-ionic) silver, oxygen and hexagonal water. Product works the better, the easier access it has to the inflammatory centre. Active ingredients (silver and oxygen ) combats harmful microorganisms: bacteria, fungi and viruses, to smaller extent moulds and protozoa. The antiseptical functioning is immediate, whereas the process of effective combating of microbes begins usually after 2-3 hours from application, and lasts as long as the particles of silver are not removed. There may be the need of multiple local application, until the symptoms disappear. It is recommended for a wide range of skin changes (abrasions, allergies, fungal infections, inflammations of the skin and muscles, infections, building ulcers, boils, eczema etc.) in any situation, when it can accelerate healing processes (even of the mucosa), as well as for disinfection and protection against the development of microorganisms (the inside of the refrigerator, food packaging, underwear, shoes, children's toys and other items).

## ATTENTION:

Despite widespread reports of an effective neutralising of numerous animate pathogens by Elixir of dr Słoń - this product should not be treated, or recommend as a drug, and especially as a panacea for all skin diseases. If the multiple application of the product do not bring the first signs of disappearing of the symptoms, it means that its active ingredients do not have access to the centre of pathogenic changes or do not interact on them, then it is always advisable to seek medical advice.

## HOW TO USE:

Before use, shake slightly. Spray the skin at the irritated area and wait to dry. Do not wash. Repeat the application until the desired effect.

## STORAGE:

Store at room temperature, in a dry place out of reach of small children.

**WARNING:** Container under pressure: protect from sunlight and heating over temperatures exceeding 50°C / 122°F. Do not pierce or burn, also after use. Should not be used after the best before date. The best before date and the batch number are marked on the bottom of the packaging.
